The following authorities were contacted: Kuwait Municipality, Ministry of Electricity and Water, General Authority for Industry, Federation of Industries, Public Authority for Agriculture and Wealth Affairs. Fishery, Ministry of Health, Ministry of Trade and Industry, Kuwait Chamber of Commerce and Industry, Kuwait University, Ministry of Higher Education, Ministry of Education, Central Administration Statistics, the General Administration of Customs, the waste department of the Environment Public Authority to collect data on mercury and its compounds and the quantities stored with them. It was found, and through the responses of the authorities, it is not possible to determine the individual stocks of mercury or its compounds present in the country that exceed 50 metric tons until complete the responses of the aforementioned authorities.

Q23 Part C. Comments regarding possible challenges in meeting the objectives of the Convention (Art. 21, para. 1)

There are challenges and difficulties in collecting data from the concerned authorities, incomplete or contrary data was received, and this hinders the reporting process. There are some responses from authorities, for example, the Ministry of Health stated that as per GCC committee and Minamata convention on mercury, the registration of products containing mercury will not be permitted after October 2019 (attached). The import of dental amalgam was banned since January 2020.
The Ministry of Electricity and Water also reported that the street lighting lamps containing mercury had been banned, and the supply of these lamps had been stopped from 3 years. The types currently used for lighting do not contain mercury.
