

Asia and the Pacific regional preparatory meeting for the second segment of the fourth meeting of the Conference of the Parties to the Minamata Convention on Mercury
Online, 7 February 2022

PROVISIONAL PROGRAMME

The Asia and the Pacific regional preparatory meeting for the second segment of the fourth meeting of the Conference of the Parties to the Minamata Convention on Mercury (COP-4.2) will be held online on **7 February 2022, from 8.00 to 12.30 Geneva time (CET)**. The working language of the meeting will be English. The online regional preparatory meeting is being organized thanks to the generous financial support provided by the Government of Switzerland.

The objective of the online regional preparatory meeting is to give parties in the region the possibility to hear briefings, exchange views and consult each other on the items of the COP-4 agenda to be considered during COP-4.2, which will be held from 21 to 25 March 2022 in Bali, Indonesia.

COP-4.2 is expected to consider and/or resume consideration of all items on the agenda of COP-4. The meeting report of the online segment of COP-4, held on 1-5 November 2021, is available on the Convention's webpage. Matters for consideration during COP-4.2 are set out in part II of Annex I of the annotated agenda of COP-4 (UNEP/MC/COP.4/1/Add.1).

Participants are invited to consult relevant meeting documents of COP-4, available on the Convention's website, in advance of the online regional preparatory meeting.

The meeting will be co-chaired by the members who represent the region at the COP-4 Bureau, Ms. Rosa Vivien Ratnawati (Indonesia) and Mr. W.T. B Dissanayake (Sri Lanka).
