

## **PROVISIONAL PROGRAMME**

Asia and the Pacific regional preparatory meeting for the fifth meeting of the Conference of the Parties to the Minamata Convention on Mercury

5 and 6 September 2023

Bangkok, Thailand

The Asia and the Pacific regional preparatory meeting for the fifth meeting of the Conference of the Parties to the Minamata Convention on Mercury (COP-5) will be held on 5 and 6 September 2023 from 9:30 to 17:00 (UTC +7), at the United Nations Conference Centre (UNCC) in Bangkok, Thailand. The working language of the meeting will be English. The regional preparatory meeting is being organized thanks to the generous financial support provided by Switzerland and Sweden.

The objective of the regional preparatory meeting is to provide Parties in the Asia and the Pacific region with the possibility to hear briefings, exchange views and consult each other on the agenda items of COP-5.

The preparatory meeting will be chaired by COP-5 Bureau members from the Asia Pacific region: Syed Mujtaba Hussain (Pakistan) and Saeed A. Alzahrani (Saudi Arabia).

Organizations approved to participate as Observers in the previous meetings of the COP have been invited to participate in the regional preparatory meeting. Upon request by Parties, the Co-chairs may decide to hold certain sessions without the presence of Observers.

Participants are invited to consult relevant meeting documents of COP-5, which will be posted as they become available on the Convention's <u>website</u>, in advance of the regional preparatory meeting.

The provisional programme for the regional preparatory meeting has been developed in consultation with the Bureau members and is presented below. The tentative schedule of COP-5 is presented in the annex to this document. Presentation of each of the matters under the agenda items will be followed by a Q&A session and discussion, as appropriate, led by the Co-chairs.
